**NOTICE OF INITIAL VIRTUAL PUBLIC COMMENT HEARINGS**

On February 17, 2023, Baltimore Gas and Electric Company (“BGE”) submitted to the Public Service Commission (“Commission”) an Application for an Electric and Gas Multi-Year Plan (“Application”). BGE also filed revised tariffs, supporting testimony, exhibits, supplemental information, and the Multi-Year Plan (“MYP”) filing requirements as adopted by the Commission in Order No. 89482.

A prehearing scheduling conference was held on March 15, 2023, during which the Commission adopted a procedural schedule for the matter, except for the schedule for evening public hearings that will be held in BGE’s service territory.<sup>1</sup>

Notice is hereby given that two initial hearings for the purpose of soliciting comments from the public will be held on Wednesday, August 9, 2023 at 7:00 p.m. and on Wednesday, August 23, 2023 at 7:00 p.m. via virtual meeting.<sup>1</sup> If you would like to speak at the hearing, please send an email to [kimberly.schock@maryland.gov](mailto:kimberly.schock@maryland.gov) by 12:00 noon on Monday, August 7, 2023 (for the first hearing) or by 12:00 noon

on Monday, August 21, 2023 (for the second hearing).<sup>2</sup> Anyone wishing to observe the live stream of the public hearing may do so via the Commission’s YouTube Channel.<sup>3</sup> Please also direct any questions about the public hearing to [kimberly.schock@maryland.gov](mailto:kimberly.schock@maryland.gov).

Written comments on this matter may also be submitted electronically or by first-class mail by September 29, 2023. Comments submitted electronically must be submitted through the Commission’s Public Comment Dropbox, which can be accessed through the Commission’s website at [www.psc.state.md.us](http://www.psc.state.md.us). Instructions for logging into the Public Comment Dropbox are located under the “Tools” section of the Commission’s website under the “Make a Public Comment” tab, which can be accessed via the following link: <https://www.psc.state.md.us/make-a-public-comment/>. Commenters utilizing the Public Comment Dropbox for the first-time are required to complete a one-time registration. All comments must include a reference to Case No. 9692. If submitted by first-class mail, comments must be addressed to Andrew S. BGE is hereby directed to publish a notice of the public comment hearing, including the caption, case number, the time, date, access information for the hearing, and the deadline for written comments as a display advertisement in

newspapers in general circulation throughout BGE's service area at least two times before August 8, 2023.

BGE is also directed to place on its homepage a notice of the public hearing in a manner that a customer need not click the link to determine the date, time, and purpose of the public hearing or the date by which public comments must be filed. Further, BGE is directed to employ any routinely used social media platforms, such as Twitter or Facebook, and any other means of communication at its disposal to further notify its customers of the public hearing and the date by which public comments must be filed.

The Commission will schedule an additional public comment hearing at a later date.
