On July 11, 2024, Baltimore Gas and Electric Company ("BGE" or "Applicant") filed an application ("Application") for a Certificate of Public Convenience and Necessity (CPCN) for authority to construct the Brandon Shores Retirement Mitigation Project, including modification and construction of overhead transmission lines that exceed 69kV in Harford, Baltimore, and Anne Arundel Counties in Maryland (the "Project").

The hearings will begin with a presentation of the Project by the Applicant, followed by a presentation by the Department of Natural Resources, Power Plant Research Program of its

recommendations with respect to the Project, followed by the Maryland Office of People's Counsel, the Technical Staff of the Public Service Commission of Maryland, Constellation Energy Generation, LLC and Constellation NewEnergy, Inc., and the Sierra Club, as to their role in the case and their recommendations with regards to the Project, if any.

Members of the public may attend this second public hearing in person to listen to the presentations by the Parties and to provide comment about the Project.¹

Written comments on the proposed Project may be submitted electronically or by first-class mail on or before May 1, 2024. Comments submitted electronically must be submitted through the Commission's Public Comment Dropbox, which can be accessed through the Commission's website at www.psc.state.md.us. Instructions for logging into the Public Comment Dropbox are located under the "Tools" section of the Commission's website under the "Make a Public Comment" tab, which can be accessed via the following link: https://www.psc.state.md.us/make-a-public-comment/. Commenters utilizing the Public Comment Dropbox are required to complete a one-time registration. If submitted by first-class mail, comments must be addressed to Jamie Bergin, Chief Clerk, Maryland Public Service Commission, William Donald Schaefer Tower, 6 St. Paul Street, 16th Floor, Baltimore, Maryland 21202. Only one copy is required. All comments must include a reference to Case No. 9748.

The Applicant is hereby directed to:

• Once in each of the four successive weeks immediately before the public hearing date:

Publish notice of the hearing, including the caption, case number, time, date, and location of the hearing, as a display advertisement in a newspaper of general circulation throughout Anne Arundel County, Baltimore County, and

Harford County, including in the notice the date by which written comments may be submitted; and

Post on at least two routinely used social media platforms, such as Facebook or X (f/k/a Twitter), and use any other means of communications at its disposal to further notify Anne Arundel County, Baltimore County, and Harford County residents/businesses of the time, date, and location of the hearing, including in the notice the date by which written comments may be submitted.²

- Post on the Baltimore Gas and Electric website a notice of the hearing, including the time, date, and location of the hearing, and the methods and date by which written comments may be submitted.
- Prominently post on the day of the hearing, no later than 3:00 p.m. (EST), an informational sign at or near each public entrance of each Hearing location, which should be at least 17 inches by 22 inches in size, and state the time, room number, and subject of the public hearing in a font size greater than 48 point and as large as the sign allows. The Applicant shall submit an affidavit certifying that the necessary properly sized informational sign(s) were posted as directed, including the time the signs were posted and a photograph of the informational sign near or at the public entrance of the building, which shall be filed with the Commission within two business days after the public hearing dates.
- File certificates of publication and postings with the Commission on or before the date of the hearing.
